VACANCY ANNOUNCEMENT

The Development Initiative for Northern Uganda (DINU), a Government of Uganda Programme supported by the European Union (EU) and supervised by Office of the Prime Minister. Together with a consortium of partners, the International Institute of Tropical Agriculture (IITA) has received a grant to implement an action named "Building resilience to enhance food and nutrition security, incomes and health in Northern Uganda". This will be implemented in seven districts of Amolatar, Apac, Lira, Otuke and Kwania in Lango sub-region, and Kapelebyong and Amuria in Teso Subregion.

Under the Market Access and Value addition Unit of the IITA-led action, Rikolto International and Kilimo Trust both consortium partners are responsible for activities of the Increased Market Accessibility Component including facilitating the strengthening of farmer organizations/ cooperatives, facilitating access to BDS such as finance for working capital to aggregate and farmer production, access to insurance as well digital solutions that aid smooth operations, payments and linkages to buyers and suppliers.

- plan, coordinate, implement and monitor actions leading to set objectives
- develop, strengthen and support business development linkages between FBOs and private companies
- strengthen the entrepreneurial attitude, skills, digital solutions and capacities of FBOs
- provide strategic and technical guidance to FBOs ensuring their inclusion in value chains
- design, test, and validate change/innovations in the linked business models













- monitor and document the change/innovations processes in the business models, the changes in behavior of the FBOs and companies involved, and the results of these towards improved smallholder livelihoods, and draw lessons
- support the periodic documentation and translation the outcomes
- coordinate/implement the actions of/with the various partners in the achievement of the set objectives of the DINU action
- build up a close relationship with private companies interested in sustainable sourcing from smallholder farmers
- network with other organizations that have a stake in the DINU action
- analyze and document the changing national context in relation to the business environment, the value chain, the market.
- provide information, analysis, lessons learned to allow program management to readjust interventions for the DINU action
- collaborate and work closely with DINU action M&E specialist and ABO's to collect and synthesize all program data and report accordingly
- develop and review plans, budgets and monitors expenditure of the DINU action in area of jurisdication
